Economic Components

A prosperous and a single market economy, with highly-skilled workforce, driven by growth-inducing productivity and innovation, that is inclusive and sustainable across and along the value chains.

This Year's Priority (2024)

Development of the Strategic Plan of the ASEAN Economic Community (AEC)

5-year Smaller Loop Planning Cycle

Under the responsibility of the High-Level Task Force on ASEAN Economic Integration (HLTF-EI), as mandated by the ASEAN Economic Ministers (AEM) at the 28th AEM Retreat

Q4 2023 to Q4 2024
