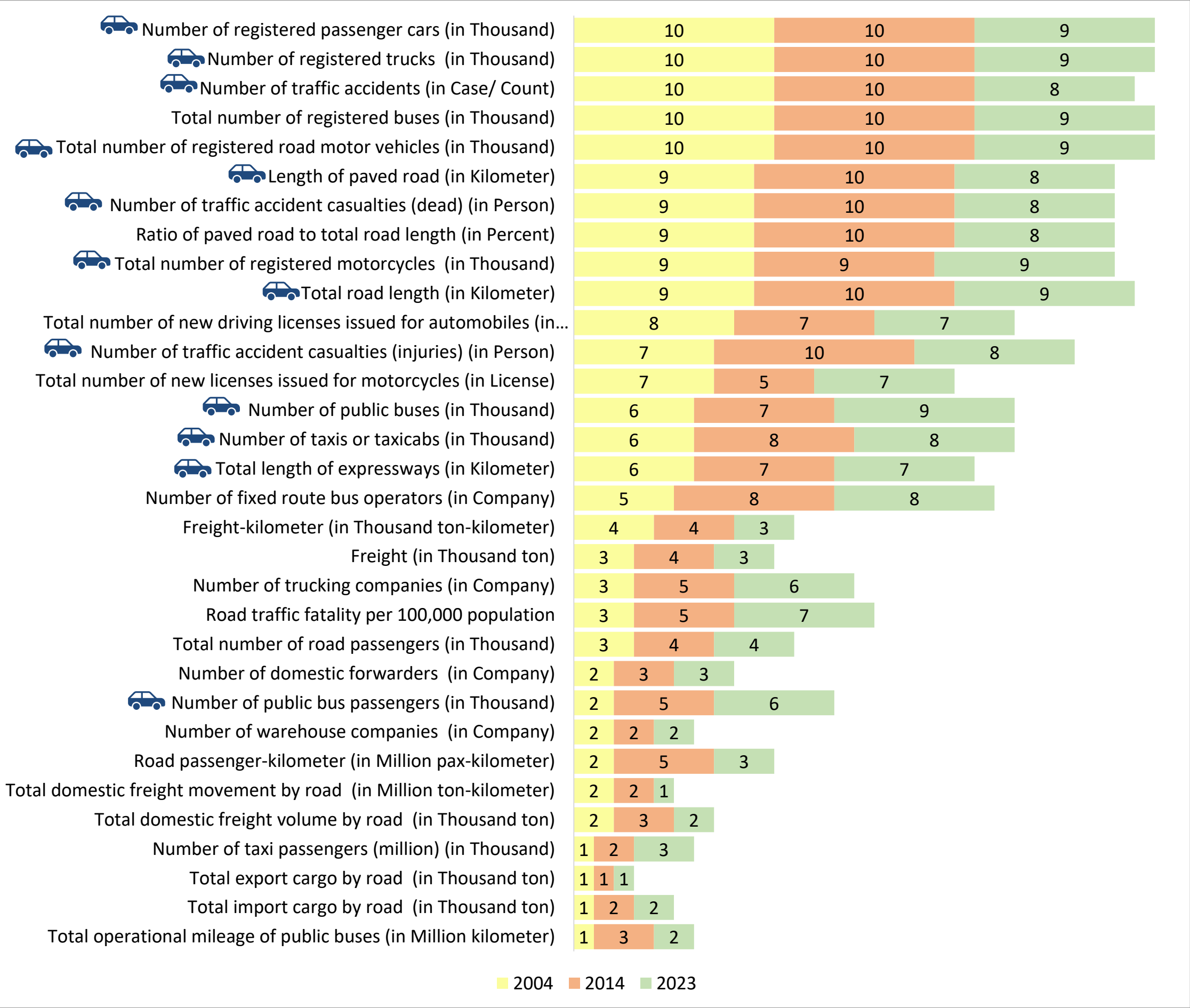

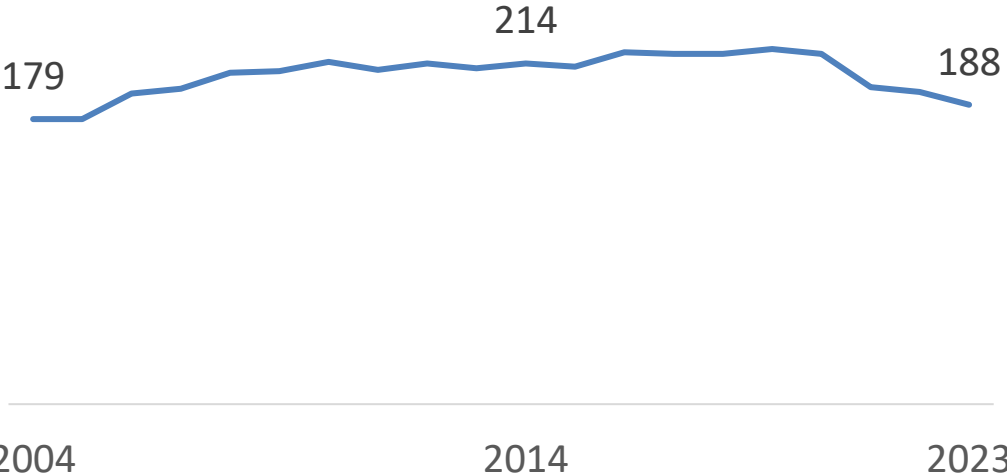

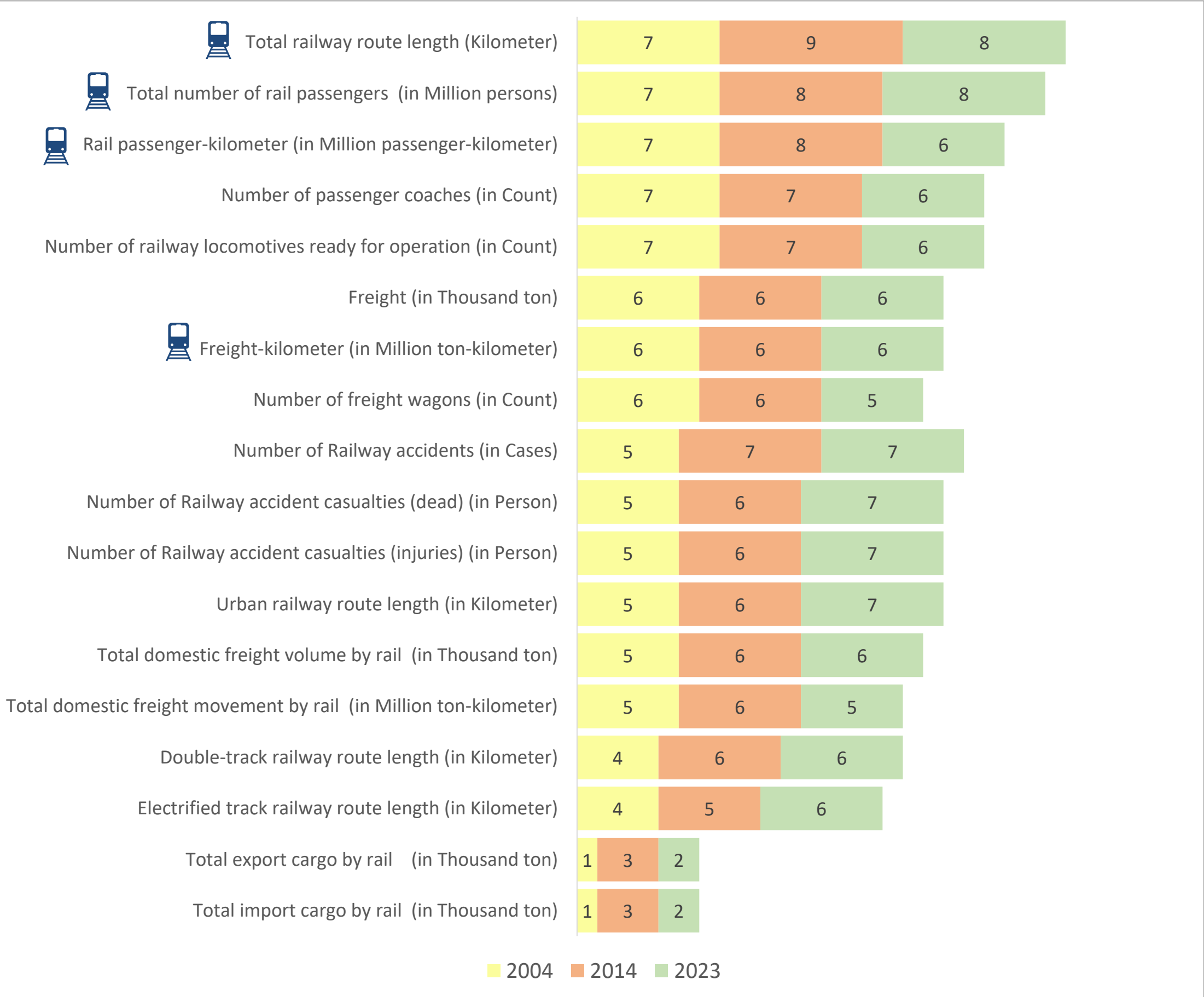
Trend Data Submission, 2004-2023



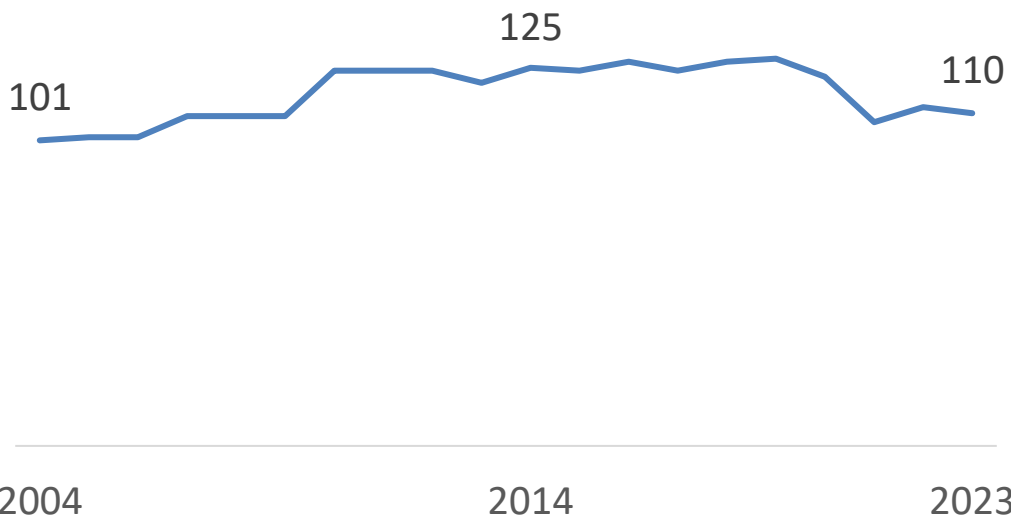

- **Data submission declined during 2021-2023.**
- **Higher submission:** registered vehicles (passenger cars, trucks, buses and motorcycles), and number of traffic accidents.
- **Lower submission:** domestic freight movement/volume, number of taxi passengers, public buses operational mileage, and total import/export cargo.

Trend Data Submission, 2004-2023



- **Data submission** rebounded in 2022 following a decline since 2019.
- **Higher submission:** railway route length, number of rail passenger, and rail-passenger-km.
- **Lower submission:** total import/export cargo.

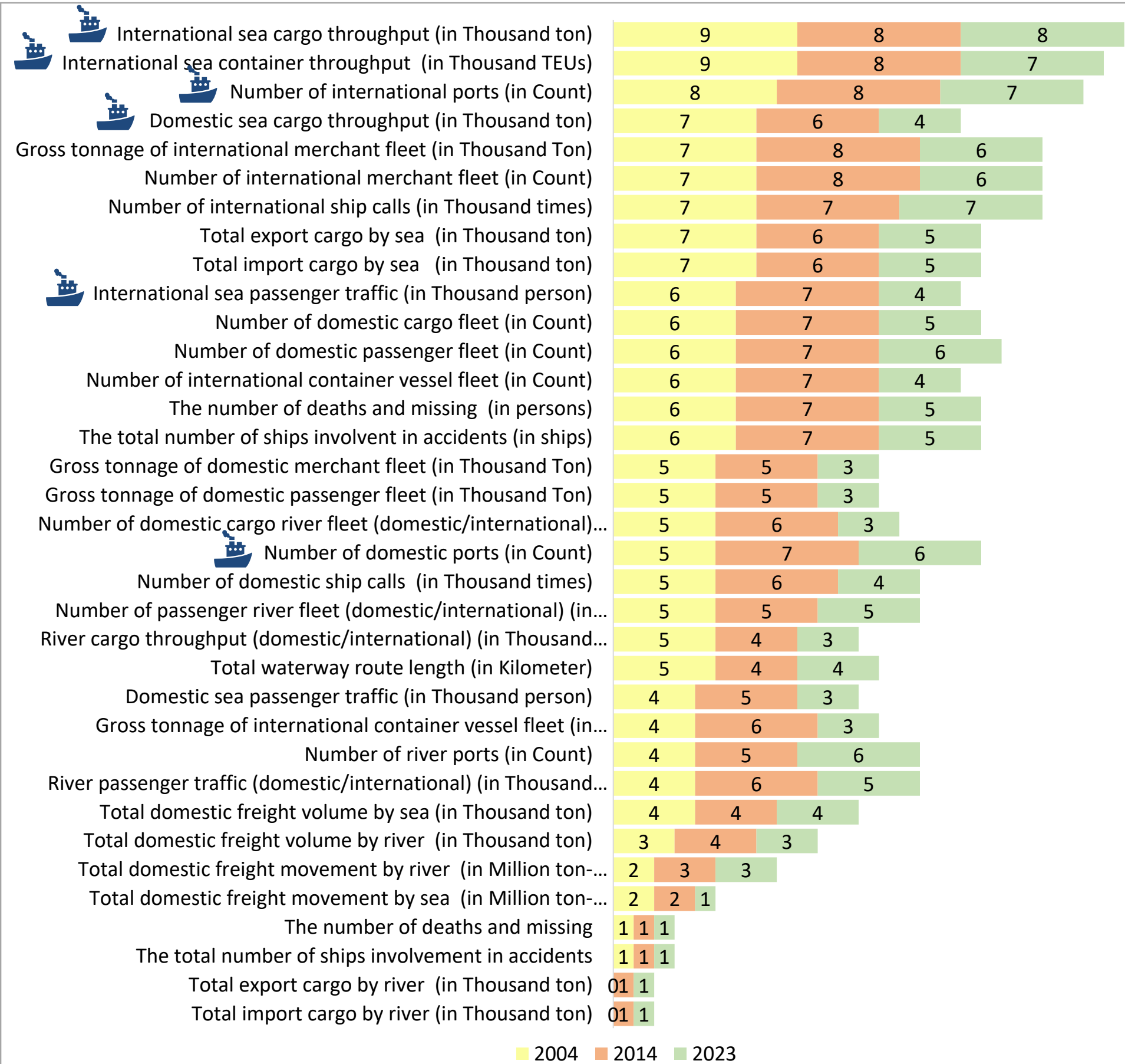

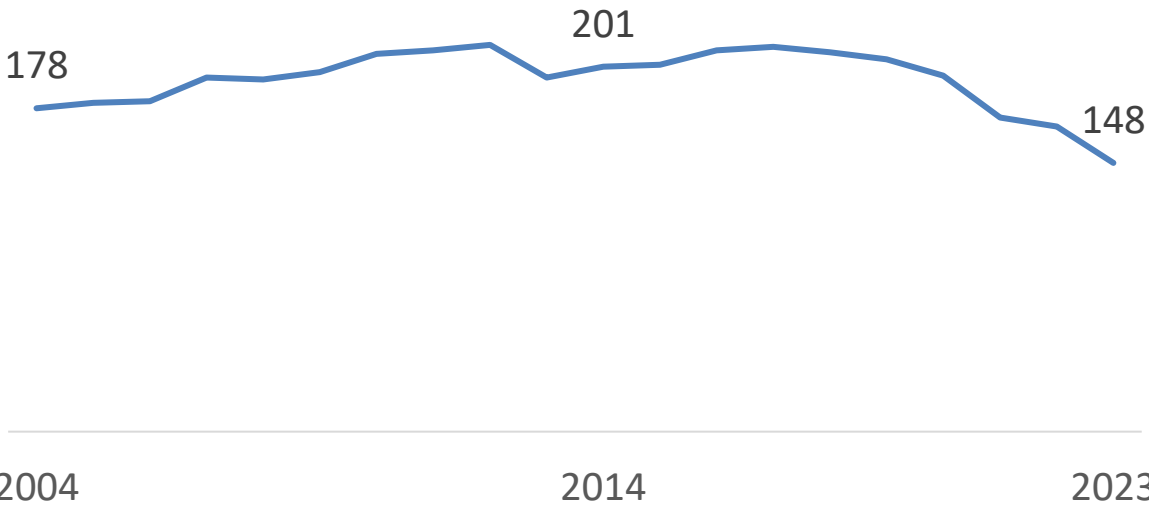

Trend Data Submission, 2004-2023

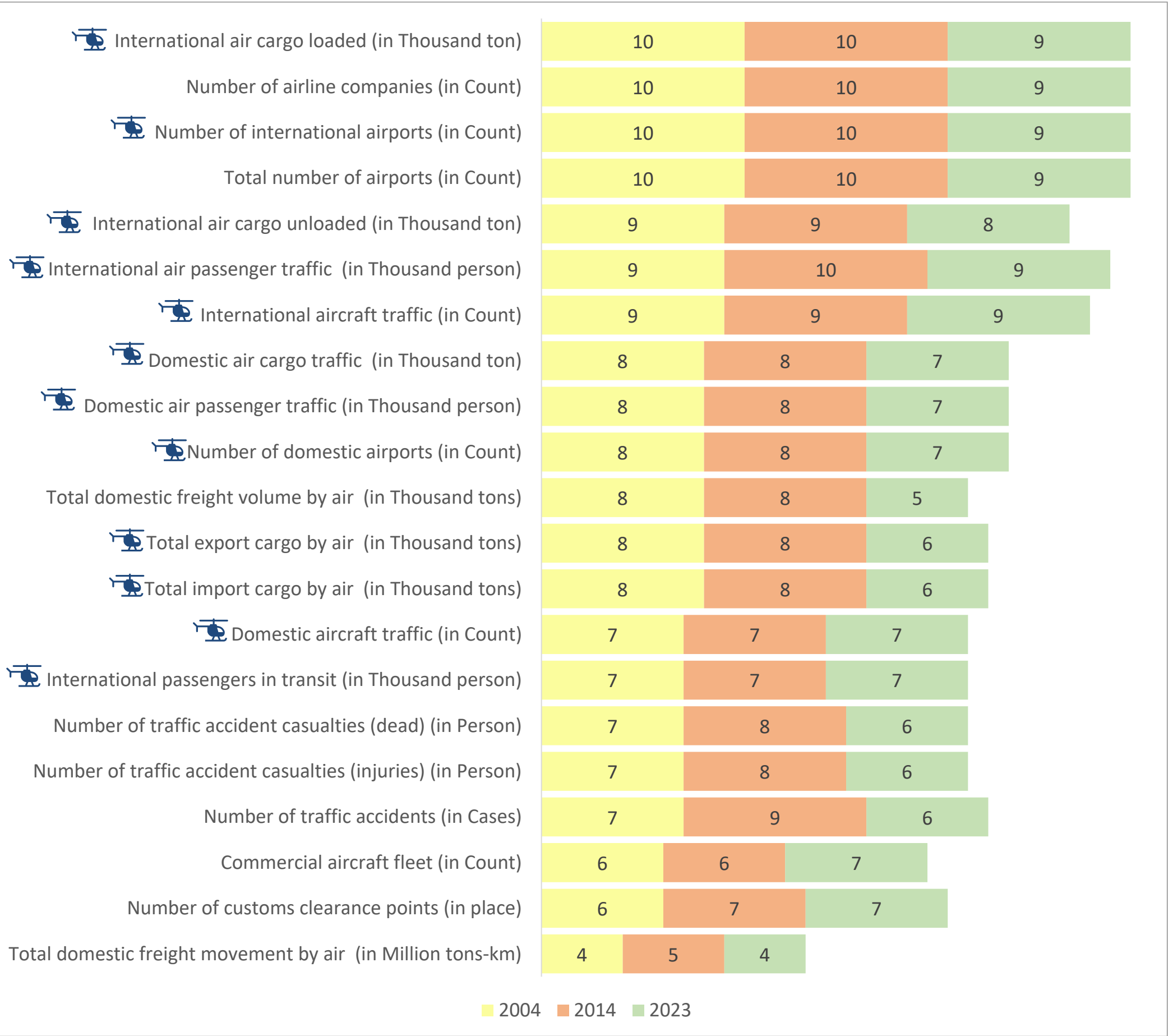


- “

 - **Lower submission:** total number of deaths & missing, number of ships involvement in accidents, and export/import cargo by river.

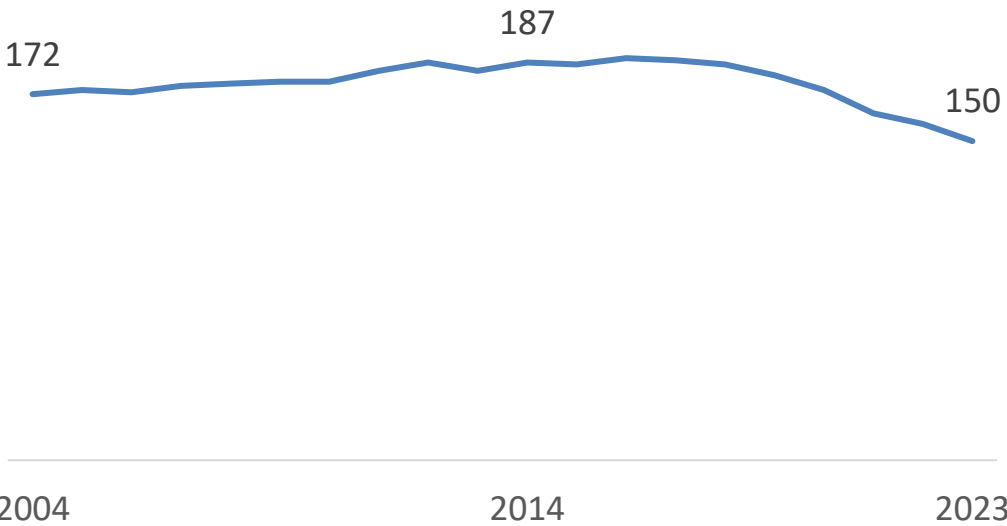

Trend Data Submission, 2004-2023



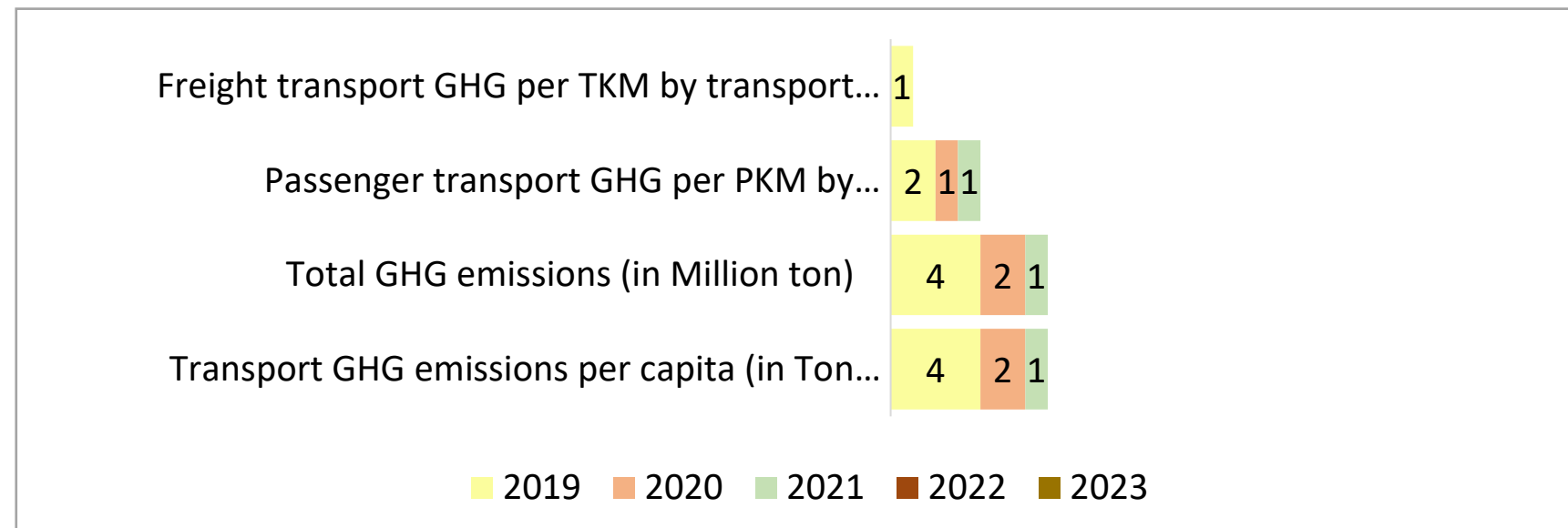
- “

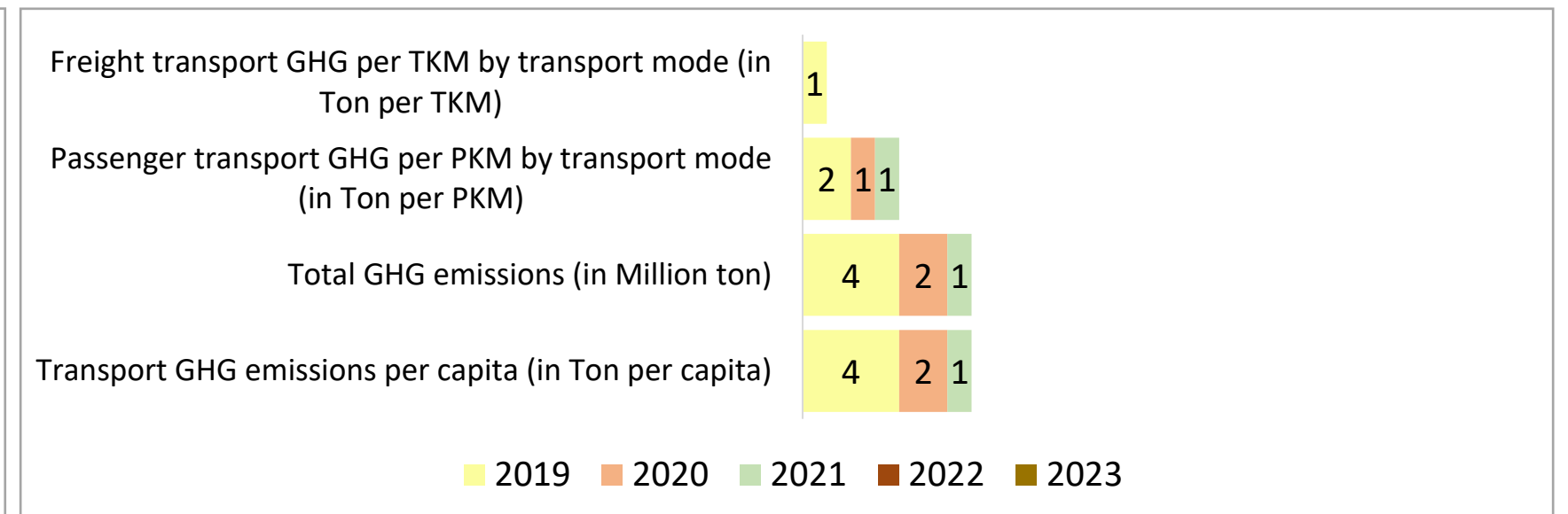

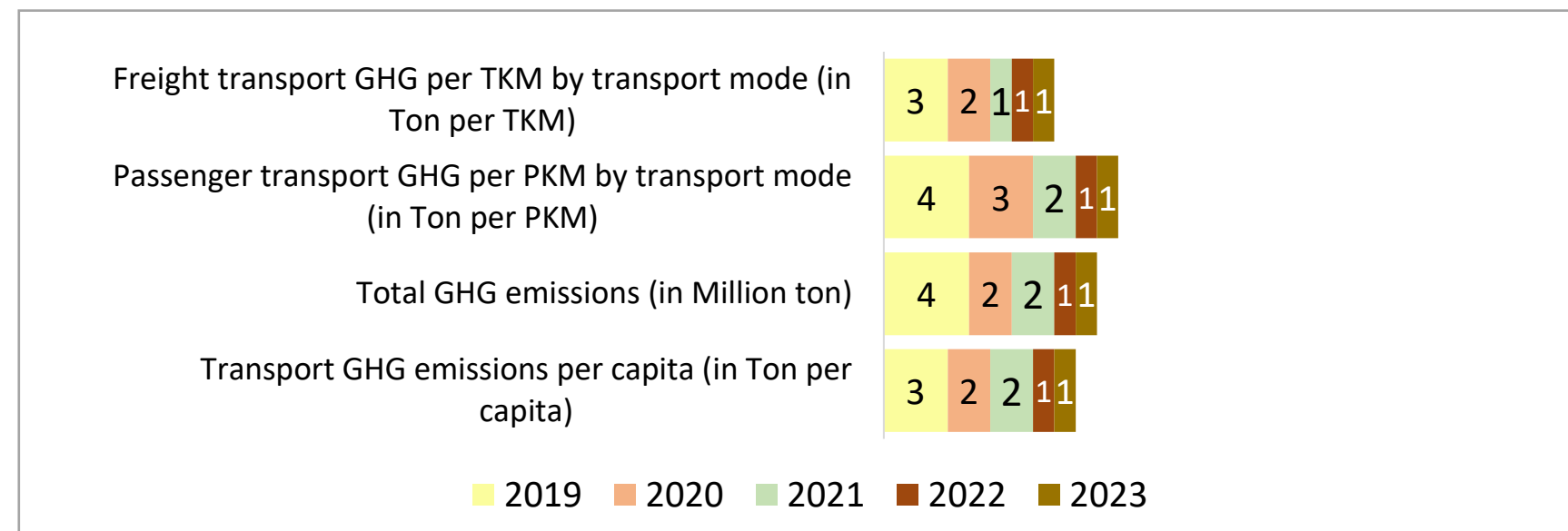

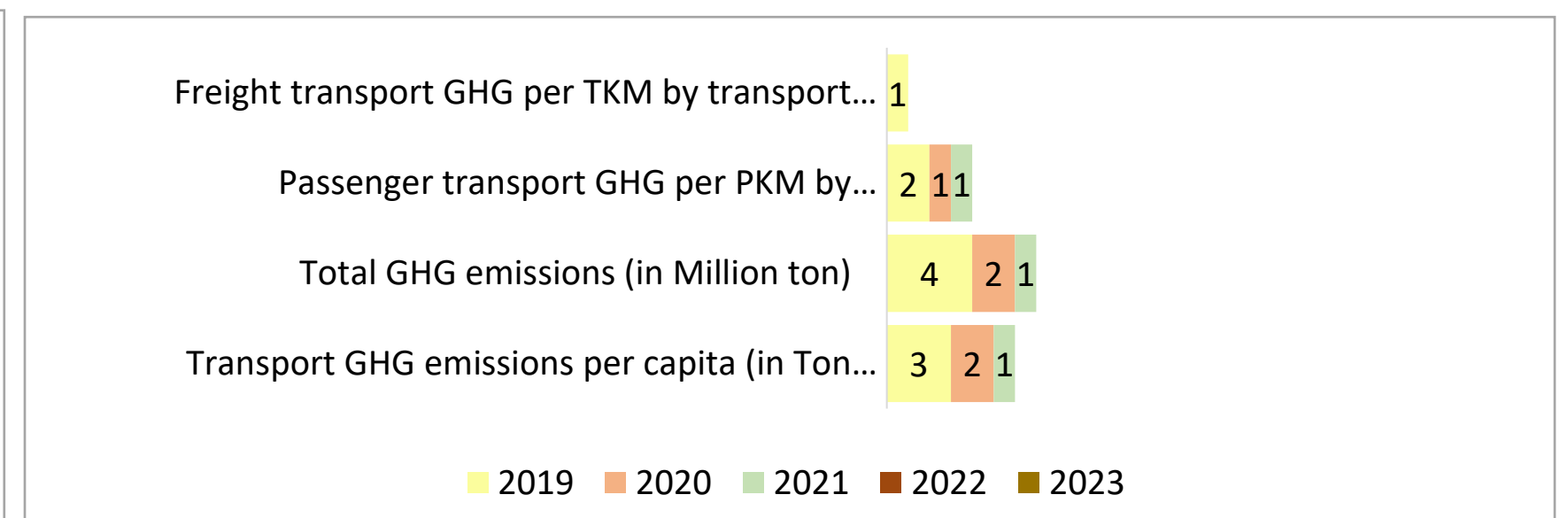

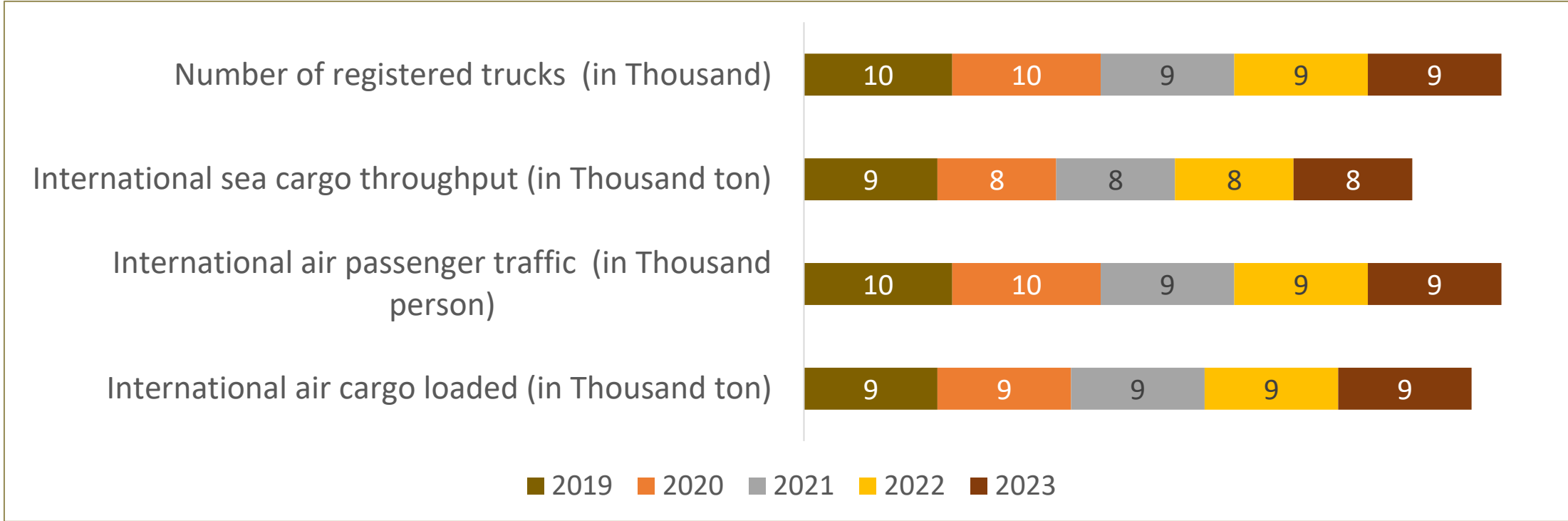


- The data on GHG for road, water, and air transport is available up to 2021. Data on GHG for rail transport is available up to 2023.

Workflow Data Confirmation

No	Activities	Time Line
1	ASEAN Secretariat (ASEC) to prepare the data confirmation template	March
2	ASEC to share the template with AMS during 18 th AJIP meeting	March
3	ASEC to send the template to AMS for their input	March
4	AMS to review the template, identify relevant indicators and submit the confirmation feedback to ASEC	April
5	ASEC to compile feedback from AMS	May
6	ASEC to process the data and refine the template for database dissemination system based on AMS feedback (1 st round data submission)	June
7	ASEC to further process the data and send to the database dissemination system (2 nd round data submission)	October
8	ASEC to share the draft database with AMS for final confirmation	October-November
9	AMS to review the draft and provide additional input or feedback	October-November
10	ASEC to finalize and disseminate the data on ASEANstats website	November
